FARMINGBURY HILLS GOLF COURSE PATRONS

The Farmingbury Hills Golf Commission is pleased to announce the season pass rates for the **2015** golfing season. We are happy to tell you that the Commission has voted to retain the same rates as the **2014 season**. **A discount of \$75.00 is offered for early bird purchasers. The discount will remain in effect until February 27th, 2015.**

The Commission is pleased to announce two changes in the 2015 season.

- 1. The age for Senior Discounts has been lowered from age 62 to 60 years.**
- 2. Persons, who pay property taxes in Wolcott but reside out of town, are eligible for resident rates at the golf course.**

The 2015 rates will apply as stated on the following page. Please note that you will also be asked to pay a \$1.50 surcharge for each 9 holes of golf. While we do not anticipate any increases in surcharges, green fees and cart fees, rates are subject to adjustment during the golfing season.

You can purchase your season pass during regular town business hours, at the Wolcott Town Hall, 10 Kenea Ave. The Wolcott Town Hall receptionist is located on the first floor. Proof of residence is mandatory. **Proof of age is required to qualify for senior citizen or junior benefits.**

Check or money order is prefer.

Before golfing privileges are granted, payment must be received in full. Please make checks payable to:

Refund Policy

Request for refunds must be submitted in writing to the Farmingbury Hills Golf Commission, C/O Town of Wolcott, 10 Kenea Ave, Wolcott, CT 06716.

Each request will be reviewed by the Farmingbury Commission. If you are requesting a refund for medical reasons, a Doctor's note or certificate must accompany your letter and will help expedite your request. Refund will be considered on a case by case basis. Authorized refunds will be pro rated base on the date of the written request. **No refunds will be authorized for any incident occurring after September 1st in any golf season.**

When a person's 60th birthday falls after that date, but within the same golfing year, they may purchase a prorated season pass for the remainder of the season. Seniors will be required to pay the \$1.50 surcharge per each 9 holes, the same as all pass holders. Carts are not included in the season pass rates.

*Juniors must be between 12 and 17 years. Persons over 17 at the start of the season are not eligible for the JR rate.

• Persons in college between the ages 18-21. College ID required.

2015 Golf Season Pass Benefits and Limitations

RESIDENT

1. **Resident**- Full play
Age 22 - 59
Able to play golf course except when tournaments are scheduled.
2. **Senior Citizen**-Full play
Age 60 & over
Able to play golf courses except when tournaments are scheduled.
3. **Senior Citizen**-Limited
Off peak hours
Age 60 & over/able to play golf course, Weekdays-must tee off by 2:30 p.m. or after 6:00 p.m. Saturday, Sunday and Holidays cannot play before 2:30 p.m.
4. **Junior**
Age 12-17
Able to play golf course:
Weekdays-must tee off by 2:30 p.m. or after 6:00 p.m.
Saturday, Sunday and Holidays cannot play before 2:30 p.m.
5. **Family**
Husband and wife able to play golf course except when Tournaments are scheduled.
Children age 12-17 same privileges as Junior.
6. **Family**
Family members between the ages of 18 and 21, living at home or in college, are included in this offering. Family members turning 22 years on or before March 31st are not included in this package offering. **NO EXCEPTIONS.** These rules apply to both resident and none resident golfers.

NON-RESIDENT

- Non-resident**-Full play
Age 22 - 59
Able to play golf course except when tournaments are scheduled.
- Senior Citizen**-Full play
Age 60 & over
Able to play golf courses except when tournaments are scheduled.
- Senior Citizen**- Limited
Off peak hours
Age 60 & over/able to play golf course, Weekdays-must tee off by 2:30 p.m. or after 6:00 p.m. Saturday, Sunday and Holidays cannot play before 2:30 p.m.
- Junior**
Age 12-17
Able to play golf course:
Weekdays-must tee off by 2:30 p.m. or after 6:00 p.m.
Saturday, Sunday and Holidays cannot play before 2:30 p.m.
- Family**
Husband and wife able to play golf course except when Tournaments are scheduled.
Children age 12-17 same privileges as Junior.

Children under 12 can play the course up until 2:30 p.m. and after 6:00 p.m. on weekdays. On Saturday, Sundays and Holidays children under 12 will be allowed to play the course after 2:30 p.m. only, while in the supervision of an adult over the age of 21.
